Appendix 3B and Secondary Trading Exemption

We attach the Appendix 3B in respect of the placement of 10,471,434 new ordinary shares at \$2.91 each being the first tranche of the capital raising of \$60.0m announced on 6 February 2018. Petra Capital Pty Ltd acted as Arranger and Lead Manager to the capital raising.

Secondary Trading Exemption
